4. First aid Measures

In case of eye contact: If in eyes, hold eyes open, flood with water for at least 15 minutes. If symptoms persist transport to nearest medical facility for additional treatment.

In case of skin contact: If skin contact occurs, remove contaminated clothing and wash skin thoroughly with water and follow by washing with soap if available

If Ingested: If swallowed, do NOT induce vomiting. Transport to nearest medical facility for additional treatment. If vomiting occurs spontaneously, keep head below hips to prevent aspiration.

If Inhaled: Keep victim calm and remove to fresh air if safe to do so. If rapid recovery does not occur, transport to nearest medical facility for additional treatment. Remove contaminated Clothing.

Symptoms caused by exposure

Inhalation: Breathing of high vapour concentrations may have a narcotic effect on the central nervous system
 Skin: May include redness and itching.
 Eyes: May include burning and temporary redness.
 Ingestion: May cause mild gastrointestinal irritation, nausea, vomiting and diarrhea.

5. Fire Fighting Measures

Suitable Extinguishing Media: Foam, water spray or fog, dry chemical powder or carbon dioxide. Do not use water in a jet

Specific Hazards arising from the Chemical:

Will float and can be reignited on surface of water. Vapour is heavier than air, can spread along ground and distant ignition is possible.

Special protective equipment for fire fighters:

Wear full protective clothing and self contained breathing apparatus. Hazchem code 3Y

6. Accidental Release Measures

Personal Precautions:

Avoid contact with spilled or released material. Shut off leaks, if possible without personal risks. Isolate hazard area and deny entry to unnecessary or unprotected personnel. Remove all sources of ignition in the surrounding area. Take precautionary measure against static discharge. Ensure electrical continuity by bonding and earthing all equipment.

Environmental Precautions:

Use appropriate containment to avoid environmental contamination. Prevent from spreading and entering waterway using sand, earth or other appropriate barriers. Attempt to disperse the vapour or to direct its flow to a safe location for example by using fog sprays. Ventilate contaminated area thoroughly.

Methods of cleanup:

For small spills (<1 drum), transfer by mechanical means to a labeled, sealable container for product recovery or safe disposal. Allow any residues to evaporate or use an appropriate absorbent material and dispose of safely. For larger spills (>1 drum), transfer by means such as a vacuum truck to a salvage tank for recovery or disposal. Do not flush residues with water. Retain as contaminated waste. Allow any residues to evaporate or use an appropriate absorbent material and dispose of safely.

7. Handling and Storage

Precautions for safe handling:

Combustible product. Avoid breathing vapours. Handle and open containers with care in a well-ventilated area. Ensure that the workplace is ventilated such that the Occupational Exposure limit is not exceeded. Avoid contact with skin, eyes and clothing. Wash thoroughly after handling. Do not eat, drink or smoke in contaminated areas. Electrostatic charges may be generated during transfer. Electrostatic discharge may cause fire. Ensure electrical continuity by earthing all equipment.

Conditions for safe storage:

Store in a well ventilated area, away from sunlight, ignition sources and other sources of heat. Do not store near strong oxidants.

8. Exposure Controls and Personal Protection

Exposure Control Measures:

 Skin protection: Use solvent resistant gloves, nitrile for longer term protection of PVC and neoprene for incidental splashes.
 Respiratory protection: If work practices do not maintain airborne levels below the exposure standard, use appropriate respiratory protection equipment. When using respirators, select an appropriate combination of mask and filter. Select a filter for organic gases and vapours (boiling point >65°C). respirators should comply with AS1716 or an equivalent approved by a state/territory authority.
